Partnership Allocation Information:

Federal Election Law prohibits corporate contributions. Partnership accounts, however, are acceptable if they are not corporate. If the contribution is drawn from a Limited Liability Company (LLC) account, Federal Election law treats it as a check drawn on a partnership account (see above), unless the LLC has opted to be treated as a corporation for federal tax purposes.
